A RESOLUTION TO APPROVE HARLINSDALE PEDESTRIAN ARTWORK RECOMMENDED BY THE FRANKLIN PUBLIC ARTS COMMISSION

WHEREAS, in 2023, the City of Franklin Public Arts Commission (the "FPAC") conducted a formal Request for Qualifications ("RFQ") for the commission of an artist to design original artwork to be installed on the Harlinsdale Pedestrian Bridge at the Park at Harlinsdale Farm; and

WHEREAS, the Franklin Public Arts Commission, reviewed the submissions and selected three (3) artists and finalists to be interviewed on June 20, 2023, and develop a proposal; and

WHEREAS, the artist selected by the FPAC for the commission of the Work was Michael McLaughlin (the "Artist"); and

WHEREAS, the Artist worked closely with the Franklin Public Arts Commission to design four (4) individual works of art (the "Work") to be sculpted in bronze and installed on the Harlinsdale Farm Pedestrian Bridge (the "Site"); and

WHEREAS, the Artist studied the Park at Harlinsdale Farm and met with the FPAC numerous times both virtually and in-person to refine the designs for the Pedestrian Bridge; and

WHEREAS, on May 15, 2024, the FPAC approved four (4) designs to be submitted for recommendation to the Board of Mayor and Aldermen for approval as seen in Exhibit A; and

WHEREAS, the Board of Mayor and Aldermen believes it is in the best interest of the City of Franklin to approve the four (4) individual designs as seen in Exhibit A to be used for the art installation on the Harlinsdale Farm Pedestrian Bridge.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF FRANKLIN, TENNESSEE, AS FOLLOWS:

- The Board of Mayor and Aldermen approve the use of the Artist, Michael McLaughlin for the design, construction and installation of artwork on the Harlinsdale Farm Pedestrian Bridge at the Park at Harlinsdale Farm.
- 2. The Board of Mayor and Aldermen approve the use of the four (4) individual designs as depicted in Exhibit A to be used for the art installation on the Harlinsdale Farm Pedestrian Bridge at the Park at Harlinsdale Farm.
