PROJECT DESCRIPTION

This project involves the reconstruction and widening of East McEwen Drive in Franklin, TN (Williamson County), from just east of its roundabout intersection with Oxford Glen Drive / Cool Springs Boulevard to Wilson Pike (SR-252), a project length of about 1.4 miles. The work to be done with this project consists of multiple utility relocations & upgrades, grading, drainage, retaining walls, bridge rehabilitation, roadway lighting, concrete curb & gutter, concrete flatwork, minor signal modifications, asphalt paving, temporary traffic control, erosion prevention & sediment control, permanent signage, and pavement markings & striping.
