Alderman Moore moved to approve Resolution 2010-40. Seconded by Alderman Petersen. Motion carried unanimously.

Alderman Burger moved to approve Ordinance 2010-41 on Second of Three Readings. Seconded by Alderman Moore. Motion carried unanimously.

Alderman Petersen moved to approve Resolution 2010-60. Seconded by Alderman McLendon. Motion carried unanimously.

NEW BUSINESS

17. Consideration of ORDINANCE 2010-55, an Ordinance to be Entitled, "An Ordinance to Rezone 22.7 Acres from Low Residential (R-1) to Civic and Institutional (CI) for Property Located Along Clovercroft Road and West of Bayhill Circle"; Establishing a Public Hearing for August 10, 2010 [First of Three Readings] Alderman Ann Petersen, FMPC Board Representative

Alderman Burger moved to approve Ordinance 2010-55 on First of Three Readings. Seconded by Alderman Bransford.

Alderman Bransford indicated she supported the rezoning on first reading to provide the opportunity for due diligence.

Alderman Burger said she had listened to the residents about issues and problems. Is this the best place to build the school? She supports the ordinance on first reading to get to the second reading and the public hearing with no promise as to how she would vote in two weeks. She will do further research and asked residents of Ward One to e-mail her as well as Trinity parents and those in the UGB. bev@aldermanburger.com, subject: School.

Alderman Skinner noted in the Work Session it was brought out that information is incomplete. He thought all information should be available by the second reading so the Board could make an equitable judgment.

Alderman Moore thought there were too many unanswered questions as well. He commented that the City would not tolerate too many applications that came in this condition. Infrastructure improvements in that area should be ranked at a higher level.

Alderman Barnhill said it would be a mistake to cut off dialogue at this point. He supported at first reading with no guarantee of how he will vote later.

Alderman McLendon stated he would vote yes to get the issue to the public hearing. He was glad the School Board leadership reached out, but is not as convinced as they are that it doesn't matter what BOMA says. He doesn't want to wrestle with this under such a deadline. The public hearing is important. In future, dialogue should occur before the purchase of property.

Motion to approve Ordinance 2010-55 on First of Three Readings carried 5-3 with Aldermen Moore, Petersen and Martin voting no.

18. Consideration of RESOLUTION 2010-30, a Resolution to Establish a Sustainable Building Policy for City of Franklin Municipal Buildings

Alderman Ken Moore Andrew Orr, Sustainability/Grant Coordinator

Alderman Moore moved to approve Resolution 2010-30 with the addition of initially in the sentence, "....shall **initially** pursue...." Seconded by Alderman Petersen.

Alderman McLendon was concerned that by passing this resolution there would be a built-in overhead, a hoop to jump through that might not work. He gave the example of the Parks equipment shed at Liberty Park. It is unlikely silver LEED would ever be pursued for such buildings. Specifying buildings over a certain square footage could cause undue cost. Making it mandatory for buildings to be LEED creates planning and financial burdens. Either water it down and say "aspire to" or raise the square footage.

Alderman Moore said "shall" is appropriate. The LEED process starts from day one. Alderman McLendon related his concern is the way the language is written. It would have to be included in the budget and analyzed to justify. Have to assume it is being done unless the Board says no because of budget or other constraints. Any delay is too much. 5000 square feet is not that big a renovation to have to go through LEED to move drywall is too much.

Alderman Moore pointed out there are many places that provide an opt out at anytime during the process. He is committed to it and LEED buildings have a payback with energy efficiency and light capturing and produce a healthier happier work force and safer environment.

Alderman Burger asked what kind of cost is incurred. Alderman Moore responded the process might be 2% and that can be analyzed up front. Alderman McLendon thought this would saddle staff with the analysis to justify why a project was not LEED certifiable.

Motion to approve Resolution 2010-30 as stated above carried 7-1 with Alderman McLendon voting no.
