SUBJECT: Carter Street Area Water and Sewer Upgrade

Purpose

The purpose of this memorandum is to present information to the Board of Mayor and Aldermen (BOMA) to consider the Final Change Order for the Carter Street Area Water and Sewer Upgrade Project.

Background

The Carter Street Area Water and Sewer Upgrade Project generally included the construction of 1,870'~6" water main, 580'~8" water main and 2,150'~8" gravity sewer. The existing water and sewer infrastructure in the Carter Street area did not effectively meet the needs of the Habitat for Humanity development and the existing development. BOMA awarded the construction contract on 1/26/2010 to L&C Contractors, Inc in the amount of \$434,185.90. At the time of Construction and Design approval, the estimated construction cost for the project was \$700,000.

At this time L&C Contractors, Inc. has substantially completed the project. The final completion of this project was delayed to coordinate our project with the Habitat for Humanity development allowing the streets to be built correctly. As part of this change order staff is requesting BOMA to adjust the contract completion date to September 30, 2010 and add an additional \$47,257.22 to cover quantity increases. The most substantial increase occurred on the asphalt paving portion of the project which was associated with roadway drainage problems and the construction of the Habitat for Humanity development.

Financial Impact

An INCREASE of \$47,257.22 to the construction contract with L&C Contractors. The final Construction contract amount will be \$481,443.12.

II. Supportive Information

This final adjustment is necessary due to over-runs and shortages in the original bid line items. The most substantial over-run occurred on the asphalt paving portion of the project which was associated with the construction of sidewalks and driveways by the Habitat for Humanity development. All paving work was overseen and approved by the City of

Franklin Streets Department. Also, an insertion valve was required to isolate an existing main which utilized project contingency funds. Additional time of 24 days past the adjusted contract completion date was used by the Contractor to complete the work.

III. Change Order Conditions

- 1. All work to be performed under this Change Order shall be carried out in compliance with the Contract Documents included in the preceding Description of Changes involved, and under the provisions of the Original Contract, including compliance with applicable specifications for the same type of work. Contract revisions associated with this change order include all overhead expenses.
- 2. This Change Order, unless otherwise provided herein, does not relieve the Contractor from strict compliance with the guarantee provisions of the Original Contract, particularly those pertaining to performance and operation of equipment.
- 3. Contractor expressly agrees that he will place under coverage of his Performance and Payment Bonds and Contractor's Insurance all work covered by this Change Order. Contractor will furnish to Owner evidence of increased coverage of his Performance and Payment Bonds for the accrued value of all Change Orders which exceeds the original Contract Price.
- 4. The costs established under this Change Order are acknowledged as including any and all costs associated with the work described herein and including any and all costs associated with any and all work performed or to be performed by the Contractor which may be affected in any manner by the work described herein.
- 5. The costs established under this Change Order are based on Contract Unit Prices. The Contractor shall be paid based on actual units performed.
