Consideration of bid award to Crutcher & Associates, LLC of Franklin in the amount of

\$31,800.00 for replacement of the awning fabric, framing and posts on Battle Park Hall at Eastern

Flank Battle Park for the Parks Department (Purchasing Office Procurement Solicitation No.

2011-008)

Purpose

The purpose of this procurement is to replace the four (4) awnings on Battle Park Hall at Eastern Flank Battle Park, 1343 Carnton Lane.

Background

Battle Park Hall at Eastern Flank Battle Park received substantial damage, including to the awnings, by high winds and heavy rain during the May 1-2, 2010 rain event.

Within the context of the bidding process, the City sought competitive pricing, on a lump-sum basis, for the following two alternate scopes of work:

- Alternate scope of work no. 1: Remove and replace existing fabric with new fabric on existing framing and posts for the four (4) existing awnings at the job site. A City of Franklin permit and plans stamped by a professional engineer would not be required for alternate scope of work no. 1.
- Alternate scope of work no. 2: Remove and replace existing fabric, framing and posts with new fabric. framing and posts for the four (4) existing awnings at the job site. A City of Franklin permit and plans stamped by a professional engineer would be required for alternate scope of work no. 2.

Financial Impact

The City published on November 4, 2010 a Notice to Bidders in the Williamson Herald for removal and replacement of awning materials with new for Eastern Flank Battlefield Park main facility at 1343 Carnton Lane, Franklin. In addition, bid documents were sent on or about the same date directly to fourteen (14) potential bidders known or thought to be interested in this solicitation. Bids from three (3) vendors were publicly opened at the bid opening held on November 16, 2010. A tabulation of the bids received for this solicitation is attached.

The apparent lowest responsive and responsible bid, from Crutcher & Associates, LLC of Franklin, is in the amount of \$12,432.00 for alternate scope of work no. 1, and in the amount of \$31,800.00 for alternate scope of work no. 2. This bid was identified because it is the lowest bid that meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation.

This awning project is not yet budgeted. The City will be pursuing reimbursement for this project once it is completed. Battle Park Hall is an insured property, so the City will be filing an insurance claim. A portion of the

loss not covered by insurance may be reimbursed by FEMA. However, it is possible that none of the project will be reimbursable.

Options

- 1. The City could accept the apparent lowest best bid for alternate scope of work no. $\underline{1}$ (replace the awning fabric only and not the framing and posts) in the amount of \$12,432.00.
- 2. The City could accept the apparent lowest best bid for alternate scope of work no. 2 (replace the awning fabric, framing and posts) in the amount of \$31,800.00.
- 3. In accordance with the bid documents, the City reserves the right to reject any and all bids.

Recommendation

In order to minimize the opportunity for surprises that could be encountered either during or after a retrofit, staff recommends that the City accept the apparent lowest best bid, from Crutcher & Associates, LLC of Franklin, in the amount of \$31,800.00 for replacement of the awning fabric, framing and posts. Purchasing Manager Brian Wilcox is of the opinion that the prepared specifications as distributed allowed for competition among multiple vendors, and that the staff recommendation appears to be made in a fair and impartial manner based upon the bids received.
