RE: Local Sales Tax Report


The local sales tax remittance from the State of Tennessee for December was \$1,767,404 compared to \$1,639,767 for the same month in 2009, an increase of \$127,637 or 7.8%. [The December remittance is for sales tax collected during the month of October, representing the fourth month of the fiscal year on an accrual basis.] During the same period, the State of Tennessee sales tax collections were up 4.4%.

Year-to-date, the City has received \$7.19 million compared to \$6.64 million in the previous year, a difference of \$556,813 or 8.4%. The State of Tennessee sales tax collections, year-to-date, were \$2.099 million compared to \$2.018 million in the prior year, a difference of \$81.6 million or 4.0%.

For budget comparisons, the City anticipated collections of \$7.09 million for the first four months of the fiscal year. Through October, the City is \$ 108,515 ahead of budgeted collections. As a further comparison, the October collection of \$ 1.77 million compares to \$1.89 million in 2007 and \$ 1.69 million in 2006.
