## MEMORANDUM

**SUBJECT:** Consideration of contract award to Modern Day Wrecking of Nashville, TN in the total amount of \$31,300 for demolition of the institutional structure, commonly known as the old jail, located at 118 Bridge Street (Purchasing Office Procurement Solicitation No. 2011-022; project not itemized in the FY 2011 budget)

### Purpose

The purpose of this procurement is to demolish the institutional structure, now informally known as “the old jail,” located at 118 Bridge Street. The purpose of the demolition is to clear this property for potential redevelopment.

### Background

The old jail, which has a brick façade and sits back from Bridge Street, is sited on the same parcel of land (map & parcel no. 063N-B06400) as the institutional structure, now informally known as “the old, old jail,” located at 112 Bridge Street, which has a concrete façade and sits close to Bridge Street.

The City acquired the parcel of property in September 2007 from Williamson County. The City subsequently determined that the property is of no further feasible use to the City and declared it surplus in August 2009. The property is presently zoned Civic-Institutional (CI) and mixed-uses complimentary to Franklin’s Historic Central District are limited under the CI zoning. Furthermore, recent changes to the City of Franklin’s Floodway Fringe Overlay have created additional challenges that limit the future reuse of this property.

In July, 2010, the City solicited sealed bids for sale of the surplus property, including both structures. One (1) bid was received by the September 2, 2010 submittal deadline. The Board of Mayor and Aldermen voted on September 28, 2010 to reject the bid and proceed with:

- evaluating and amending the Floodway Fringe Overlay restrictions that significantly limit uses
- rezoning of the property
- re-soliciting

Since September, the Historic Zoning Commission acknowledged staffs plans to demolish “the old jail” and remove the building permanently from the floodplain and the Board of Mayor and Alderman will soon consider rezoning the parcel from Civic Institutional (CI) to Central Commercial (CC), which coincides with the adjacent properties and provides the opportunity for complimentary uses.

### Financial Impact

The City published on March 10, 2011 a Notice to Bidders in the *Williamson Herald* for demolition of the institutional structure, commonly known as the old jail, located at 118 Bridge Street, Franklin, TN. In addition,

bid documents were sent on or about the same date directly to 23 potential bidders known or thought to be interested in this solicitation. Bids from four (4) vendors were publicly opened at the bid opening held on March 24, 2011. A tabulation of the bids received for this solicitation is attached. The apparent lowest, most responsive and responsible bid, from Modern Day Wrecking of Nashville, is in the total amount of \$31,300 for the specified services. This bid was identified because it is the lowest bid that meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation. Please note that this project, the cost of which would be allocated to the Water Fund inasmuch as the property is an asset of the Water Fund, is not specifically itemized in the Water Fund budget for fiscal year 2011.

### **Options**

In accordance with the bid documents, the City reserves the right to reject any and all bids.

### **Recommendation**

Staff recommends that the City accept the apparent lowest best bid, from Modern Day Wrecking of Nashville, in the total amount of \$31,300 for the specified services. Purchasing Manager Brian Wilcox is of the opinion that the prepared specifications as distributed allowed for competition among multiple vendors, and that the staff recommendation appears to be made in a fair and impartial manner based upon the bids received.
