Solutions, of Ellisville, Mississippi for four (4) different models of laptop computers to

be allocated to various departments of the City (Purchasing Office Procurement

Solicitation No. 2011-029)

Purpose

The purpose of this procurement is to establish unit pricing for anticipated purchase of laptop computers for the various departments, divisions and offices of the City as needed.

Background

Each fiscal year, the City budget allocates funds for the purchase of computer hardware for each cost center on an as needed basis. Computer hardware is ordered by the MIT Department to meet the justified needs of the end-user. Purchases of computer hardware are allocated and expensed to the City cost center to which the end-user is assigned. The City has purchased laptop computers in the recent past using Tennessee statewide contracts. The MIT Department decided the City should solicit its own unit pricing at this time, such pricing to be valid through June 30, 2012 or until the specified units are no longer available for purchase new, whichever comes first, for the following four different hardware and software configurations:

- HP6550B i5/460M 2.53GHz Processor, 15.6" display (WXGA 1366x768), Windows 7 Professional, 32-bit, 4GB RAM, 320GB Drive, DVD-Writer, 6-hr battery, 5.5 lbs, one-year warranty, carrying case.
- HP6550B i5/460M 2.53GHz Processor, 15.6" display (WXGA 1366x768), Windows 7 Professional, 64-Bit, 4GB RAM, 320GB Drive, DVD-Writer, 10-hr battery, 5.5 lbs, one-year warranty, carrying case.
- HP8540P Intel core i5-560M 2.66GHz Processor, 15.6" display, Windows 7 Professional, 32-bit, 2GB RAM, 320GB Drive, Bluetooth, webcam, DVD-Writer, three-year limited warranty, carrying case.
- HP8540P Intel dual-core i7-640M 2.8GHz Processor, 15.6" display, Windows 7 Professional, 64-bit, 4GB RAM, 320GB Drive, Bluetooth, webcam, DVD-Writer, three-year limited warranty, carrying case.

Financial Impact

The City published on March 10, 2011 a Notice to Bidders in the *Williamson Herald* for laptop computers. In addition, bid documents were sent on or about the same date directly to six (6) potential





bidders known or thought to be interested in this solicitation. Bids from two (2) vendors were publicly opened at the bid opening held on March 31, 2011. A tabulation of the bids received for this solicitation is attached. The apparent lowest, most responsive and responsible bid is from Howard Industries, Inc., d/b/a Howard Technology Solutions, of Ellisville, Mississippi. This bid was identified because it consists of the lowest unit pricing for each of the four (4) specified hardware and software configurations that meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation.

Options

In accordance with the bid documents, the City reserves the right to reject any and all bids.

Recommendation

Staff recommends that the City accept the apparent lowest best bid, from Howard Industries, Inc., d/b/a Howard Technology Solutions, of Ellisville, Mississippi for the specified laptop computers. Over the course of the next fifteen (15) months, substantially more than \$10,000 of City funds budgeted for computer hardware will very likely be spent on laptop computers of one of the specified configurations or another. Purchasing Manager Brian Wilcox is of the opinion that the prepared specifications as distributed allowed for competition among multiple vendors, and that the staff recommendation appears to be made in a fair and impartial manner based upon the bids received.
