I. Debrief of Stakeholder Workshop

A. Steering Committee Feedback

CDM received feedback from the steering committee on the recent Stakeholder Workshop on June 1st. Overall the impression on the content and feedback from the Stakeholders was good; the Workshop presentation slides will be placed on the IWRP website.

B. Stakeholder/Public Question and Responses

There was interest by the Stakeholders to review the specifics on the technical information discussed in the Workshop; CDM still needs feedback from the Steering Committee on two biosolids memoranda and the water treatment plant memorandum before they can be posted for public access.

II. Water Distribution System Analysis

The City does not have a formal water distribution system master plan document. The City responds quite well to system demands, however, in order to complete the analysis as scoped for the IWRP, CDM requires information regarding future water demands. In order to complete the task with the information that is available, the Steering Committee agreed to use the information from SSR on growth projections and the most recent information on customer demands to generate projections that are distributed throughout the existing system.
