SUBJECT: Consideration of multiple awards for legal counsel and professional services pertaining to real

estate closings for the City's voluntary purchase and sale of real estate or its acquisition by eminent domain for City public works projects and other public purposes, through June 30, 2013 (Purchasing Office Procurement Solicitation No. 2012-008; fees to be allocated to the projects to

which the services pertain)

Purpose

The purpose of this procurement is to purchase, on an as-needed basis, for legal counsel and professional services pertaining to real estate closings for the City's voluntary purchase and sale of real estate or its acquisition by eminent domain for City public works projects and other public purposes.

Background

The Law Department, in conjunction with the Engineering Department, has need from time to time to engage outside counsel qualified to provide legal counsel and professional services pertaining to real estate closings for the City's voluntary purchase and sale of real estate or its acquisition by eminent domain for City public works projects and other public purposes, in exchange for fees based on rates quoted in the service provider's submittal. The Law Department has requested that this arrangement be effective through June 30, 2013. The purpose of this procurement is to allow the City to request services from all qualified vendors in rotation for professional real estate closing legal counsel, as a rule on a project-by-project basis, with the same firm doing all closings with respect to the same public works project. The City may alter this practice at its sole discretion in cases where a particular project involves a large number of closings or for any other reason. The order of priority on the list shall be established by the City's Law Department by some random selection method. The City will use best efforts to see that closing work is equitably allocated among firms on the qualified list, but does not guarantee any vendor any particular number of assignments per year or that the assignments will in fact be evenly divided. A vendor may decline a particular assignment or withdraw from the list during the year without penalty.

The City published on June 30, 2011 a Notice to Vendors in the *Williamson Herald* for professional services pertaining to legal counsel and professional services pertaining to real estate closings for the City's voluntary purchase and sale of real estate or its acquisition by eminent domain for City public works projects and other public purposes. In addition, solicitation documents were sent on or about the same date directly to eleven (11) potential vendors known or thought to be interested in this solicitation. Submittals from seven (7) vendors were publicly opened at the submittal opening held on July 14, 2011. A tabulation of the submittals received for this solicitation is attached. None of the submittals indicate the need for any of the service providers to take any exceptions to the City's solicitation.

Financial Impact

Fees for closing services rendered, at the rates quoted in the service provider's submittal, will be allocated to the projects to which the services pertain.

Options

In accordance with the solicitation documents, the City reserves the right to reject any and all submittals.

Recommendation

Staff recommends that the City accepts and declares responsive and responsible the seven (7) submittals received in response to the City's solicitation for closing services. Purchasing Manager Brian Wilcox is of the opinion that the prepared solicitation documents as distributed allowed for competition among multiple vendors, and that the recommendation appears to be made in a fair and impartial manner based upon the submittals received.
