SUBJECT: Consideration of bid award to Walker Chevrolet, Inc. of Franklin, TN in the total amount of \$36,471.00 for a quantity of one (1) four-door one-ton pickup truck with diesel engine for the Parks Department (Purchasing Office Procurement Solicitation No. 2012-017; \$37,500.00 budgeted in 110-89520-44700 for fiscal year 2012)

Purpose

The purpose of this procurement is to purchase a quantity of one (1) four-door one-ton pickup truck with diesel engine for the Parks Department. This new truck would be used to haul equipment and tools, and to pull a gooseneck trailer, and would be an expansion to the Parks Department's fleet of vehicles.

Background

The City published on November 17, 2011 a Notice to Bidders in the *Williamson Herald* for a minimum of one (1) new one-ton pickup truck, and a minimum of one (1) new one-ton flatbed truck. In addition, bid documents were sent on or about the same date directly to ten (10) potential bidders known or thought to be interested in this solicitation. Bids from three (3) vendors were publicly opened at the bid opening held on November 29, 2011. A tabulation of the bids received for this solicitation is attached.

Financial Impact

The apparent lowest, most responsive and responsible bid, from Walker Chevrolet, Inc. of Franklin, TN, is in the total amount of \$36,471 for a quantity of one (1) four-door one-ton pickup truck with diesel engine. This bid was identified because it is the lowest bid that most closely meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation. The Parks Department budget for fiscal year 2012 allocates \$37,500.00 out of the General Fund for the purchase of a one-ton truck with a utility bed. The Walker Chevrolet bid amount is \$1,029.00 (2.7%) under budget.

Options

In accordance with the bid documents, the City reserves the right to reject any and all bids.

Recommendation

Staff recommends that the City accept the apparent lowest best bid, from Walker Chevrolet, Inc. of Franklin, TN, in the total amount of \$36,471 for a quantity of one (1) four-door one-ton pickup truck with diesel engine. Purchasing Manager Brian Wilcox is of the opinion that the prepared specifications as distributed allowed for competition among multiple vendors, and that the staff recommendation appears to be made in a fair and impartial manner based upon the bids received.
