SUBJECT: Consideration of contract award to Taleo Corporation (Contract No. 2011-0185)

---

### **Purpose**

The purpose this purchase is to acquire an online applicant tracking software that will allow the City to be more strategic and efficient in its recruitment and selection efforts while providing a better overall experience for applicants and staff. The system should also substantially reduce our time to fill a vacancy.

### **Background**

The Human Resources Department processed approximately 3,000 applications for over 50 externally-posted job vacancies in 2010. Currently, the City does not have a software system in place to help manage its recruitment and selection processes resulting in an average of 125 days to fill a vacancy.

An applicant tracking system will enable the City to create, store, and modify online employment applications. Applicants can receive electronic updates regarding the status of their application. Additionally, candidates can request notification when a position in which they are interested becomes available.

An applicant tracking system will provide many benefits to the Human Resources Department including but not limited to the ability to automatically screen applications based on pre-determined criteria; query applicants by skill sets, education, and relevant experience; automatically post vacancies to selected media sources; and report on Equal Employment Opportunity (EEO) data, recruiting sources, cost data. etc.

In 2009, the City began looking at HR software solutions and has viewed demonstrations of 12 programs and received quotes from five vendors. Some of these programs are all-encompassing while others specialize in a particular need such as applicant tracking. The Human Resources staff team believes that an applicant tracking system is the greatest software need and would have the most impact for the City organization. Through extensive research, staff has found that

Taleo is a leader in the industry and best suits the City's need for an applicant tracking system at the most reasonable cost.

### **Financial Impact**

A two-year contract is being proposed. The cost for calendar year 2012 is \$19,840 and includes the annual subscription fee and one-time implementation and training fees. The cost for calendar year 2013 is \$14,625. After the two-year contract period the City can renew the subscription each year at the price of \$14,625. Because it is software as a service (SASS) all maintenance is included in the annual price. Our capital budget includes \$100,000 for HRIS software. The contract amount should be offset by the reduction in personnel hours allowing us to use those hours in other areas of Human Resources and be more proactive in our work.

### **Recommendation**

Approval of a contract award to Taleo is recommended..
